

Camp Good Dog! Board & Train Services Agreement

This Agreement between _____ of _____ (hereinafter referred to as "Client") and Gina Johnson acting as agent for One Good Dog! Professional Dog Training (hereinafter known as "Trainer") pertains to the following:

For good and valuable consideration, the parties agree as follows:

Health/Medical: Client shall provide documentation of up-to-date vaccinations including Rabies, DHLPP, Bordatella and Corona. Dog must be on monthly flea/tick preventive or treated on an as needed basis. Client agrees that if at any time Trainer deems that Dog needs urgent veterinary care, Dog shall immediately be taken to a local veterinary clinic. If veterinary care is not deemed urgent, every attempt will be made to notify client before bringing Dog to veterinarian. Client agrees to pay any associated veterinary bills.

Training Fees: Client agrees to pay Trainer a nonrefundable fee in the amount of \$_____ for a _____ day board and train package. Fees are payable in advance of commencement of training. Fees include _____ session(s) with Client, to be held at _____, the purpose of which is to instruct Client on how to work with Dog on behaviors that have been taught.

Services: Trainer agrees to provide one-on-one training for Dog at Trainer's home and surrounding community (hereinafter referred to as "Facility"). This training consists of, and is not limited to, basic on-leash behaviors including sit, down, wait, down-stay, leave it, off, recall (come) and loose leash walking. Dog problem behaviors that are to be worked on during this board and train phase, if any, will be written out as an addendum to this contract and signed by both parties.

Trainer will make every reasonable effort to train Dog to perform the aforementioned skills, and will demonstrate or provide Client with a videotape of Dog successfully performing these behaviors. However, Trainer does not make any guarantee of Dog's future performance or behavior as a result of providing training at Facility. Client understands that without practicing and reinforcing these behaviors at home, they will naturally become less reliable over time.

Liability: Trainer agrees to exercise due and reasonable care of Dog while at Facility. However, Trainer is not liable for loss or damage from disease, death, running away, theft, fire, injury to persons, other dogs, or property by Dog during or after the term of this Agreement. Client agrees to pay all resulting losses and damages suffered or incurred, and to defend and indemnify Trainer, her employees and agents from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney fees.

At Trainer's sole election, Trainer's duties hereunder shall terminate if (a) in Trainer's sole judgment Dog is dangerous or vicious to Trainer or any other person or animal, or (b) Client breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, Trainer's duties shall terminate but all other provisions of this Agreement shall continue in full force and effect.

This Agreement supersedes all prior discussions, representations, warranties and agreements of the parties, and expresses the entire agreement between Client and Trainer regarding the matters described above. The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations or oral understandings have been made with regard to Dog or anything else. Client acknowledges that Trainer has not represented, promised, guaranteed or warranted that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavioral problems, or that the results of the training will last for any particular amount of time. This Agreement may be amended only by a written instrument signed by both Client and Trainer.
